## K – 12<sup>TH</sup> TUITION & FEES 2022-2023

Registration and Book fees are paid at the time of enrollment and are non-refundable.  
Registration for 3<sup>rd</sup> child is waived.

Early registration fee:	\$100 (December 26, 2021 – February 11, 2022)
Registration Fee:	\$180
Book/Technology Fee K-5:	\$125
Book/Technology Fee 6-12:	\$190 (includes yearbook)

### K – 12<sup>th</sup> Tuition Schedule

Grade	Annual Tuition	12-Month July-June
K-5 – 5 <sup>th</sup>	\$5,702	\$475/mo
6 <sup>th</sup> – 8 <sup>th</sup>	\$5,835	\$486/mo
9 <sup>th</sup> – 12 <sup>th</sup>	\$6,190	\$516/mo

\*Monthly fees are determined based upon enrollment date.  
Those enrolling after July 1 will be set up on a different payment plan.

- Tuition may be paid in full, or on a 12-month plan (July-June).
- Tuition Assistance applications & Pastoral applications are available upon request and must be applied for annually and are due by May 1st. Current year's tax documents must be presented with Tuition Assistance application.

### FAMILY TUITION DISCOUNT PLAN

- One payment – Families who choose to pay their tuition in full by August 1, 2022 will receive a \$100 discount off their total tuition.
- Multi-Student – Families with more than one student are eligible to receive a 15% discount starting with the second child and applies to all grades K5-12<sup>th</sup>.
- Ask us about our large family (3 or more children) tuition cap.

### EXTENDED CARE 2022-2023

- Extended care is optional for students for the additional fee listed above.
- Fees for extended care include all regularly scheduled school days, except some days prior to breaks.
- If school is closed due to inclement weather, there will be no extended care offered.

### Payment Policy:

- Registration and Book Fees are non-refundable. Tuition payments are due by the 3<sup>rd</sup> of each month. Any balance remaining unpaid after the due date shall incur a late fee of \$25.00/mo.
- Financial obligation, penalties, and payment procedures are listed within the Financial Contract.
- Returned payments from your financial institution will be assessed a \$30 FACTS returned payment fee.
- All families are required to establish a FACTS account and pay through the FACTS portal via credit card or automatic withdrawals.
