Dear Parents,

February has quickly rolled around and it is time for re-enrollment for the 2018-19 school year. In a culture that struggles with absolutes, a Christian education founded upon God's Word is indeed valuable. Noah Webster stated this: "Every civil government is based upon some religion or philosophy of life. Education in a nation will propagate the religion of that nation. In America, the foundational religion was Christianity. And it was sown in the hearts of Americans through the home and private and public schools for centuries. Our liberty, growth, and prosperity was the result of a Biblical philosophy of life. Our continued freedom and success is dependent on our educating the youth of America in the principles of Christianity." We believe your investment in your child's education is well worth the sacrifice you make to have your children enrolled here.

The Board is aware of the financial sacrifices that you make to send your young person to FCA. The Board continues to manage a 3-year budget plan to assist us in closing the gap between income and expenses. It will be important to turn in Tuition Assistance papers by April 27th. The Tuition Aid Committee will review the requests and reply by May 15th. Applications that do not include all the requested information will not be considered. We urge you to seek other methods of tuition assistance before turning to the school for your request.

Registration for current families begins February 1, 2018 with the registration rate being \$80.00 plus book and technology fees in the month of February. In March registration increases to \$100.00 plus book and technology fees. After April 30, 2018 the registration fee increases to \$175.00. We would encourage your family to benefit from the savings by enrolling during the month of February. You may go to RENWEB and re-enroll online. Click on the re-enroll button and follow the arrows and procedures given and you will be able to update all family information and re-enroll your child(ren). Payment of registration, book, and technology fees must be completed in the school office OR you may pay online. An email will follow to allow you to do this. You are considered re-enrolled when registration and fees have been paid.

If you struggle with the cost of tuition, please feel free to contact us. We want everyone to be able to afford the education at Faith Christian Academy. You may pick up a tuition assistance application from the main office or download an application from the website. The application is due back to the main office by April 27th along with a copy of your tax return. We have some limited funds to help families struggling financially due to the economy or job challenges. If you know of a family who has children kindergarten or 6th grade ages, who desire to enroll at FCA, there is a special scholarship opportunity through VA Children's Tuition Fund. We have been able to give scholarships through Virginia Children's Tuition Fund.

Thank you for allowing us to assist you in the education and Biblical training of your child.
